(b) Online Application Form:

(i) The application for Surrender Certificate must be completed and submitted online. The form can be filled up and submitting online at the below link:

(ii) Must select the correct Indian High Commission / Consulate, based on the place where you reside in Canada and within the Consular jurisdiction of Indian High Commission / Consulate. The Consular jurisdition should be Canada-Vancouver. The consular jurisdiction can be seen at below link:

- (iii) Applicant submitting the application for the first time needs to register and make an account to fill online application. If already registered, Please log in and fill the application.
- (iv) Forms to be filled in the current year
- (v) Complete the application, print and sign
- (vi) After online submission of application form, no changes can be made manually / hand writing. In case of any error / changes, please fill a fresh new online application form and use that for further submission to BLS.

Please note:

- (a) BLS International Employees cannot edit or make any changes to your online application form.
- (b) High commission / Consulate reserves the Right to Call for Additional Documents, as considered necessary

(c) Last held Indian Passport (Original and self-attested copy)

To obtain the Surrender Certificate, the applicant is required to submit the last held Indian Passport in Original and photocopy.

With the application, please enclose original Passport and copy of the first page and last page of your Indian Passport having photographs and other details. If there are any endorsements on the page, kindly enclose copy of those pages as well. Copies must be self-attested (signed) by the applicant.

(d) Citizenship certificate (self-attested copy)

Please enclose copy of your Canadian / Foreign Citizenship Certificate. If Citizenship certificate is not available, you can enclose copy of your Citizenship card. Copies must be self-attested (signed) by the applicant.

(e) Canadian / Foreign Passport (Original and self-attested copy)

Please enclose photo page of your Canadian / Foreign Passport having photographs and details of your passport. Original Passport is required to be submitted for verification, it will be returned back after verification. Copies must be self-attested (signed) by the applicant.

In case of foreign passport i.e., other than Canadian please provide additional documents about Status in Canada (PR / Work Permit / Study Permit / Visa)

(f) Proof of address in Canada (self-attested copy)

Please enclose any one of the following document as proof of present address:

- (i) Driving License
- (ii) Photo ID issued by the Provincial Government
- (iii) Utility Bills(Electricity/water/Gas any one) -must be recent

Note: Address proof must match with the address provided in the application form. Copies must be self-attested (signed) by the applicant.

(g) Photograph
